



## **AECOM wins contract for Abu Dhabi's Masdar Institute Neighborhood**

LOS ANGELES--(BUSINESS WIRE)--Nov. 18, 2009-- AECOM Technology Corporation (NYSE: ACM), a leading provider of professional technical and management support services for government and commercial clients around the world, announced today that it has been awarded a contract to provide project, design and construction management as well as construction supervision for the Masdar Institute Neighborhood (MIN) development in Masdar City, Abu Dhabi.

Masdar City is a 1,729-acre, US\$22-billion development and the future home of the International Renewable Energy Agency. It is designed to be a carbon-neutral, zero-waste city.

AECOM's contract fee was not disclosed.

The MIN development is adjacent to the Masdar Institute of Science and Technology and will include residential, hospitality, commercial and retail developments as well as parks and playgrounds.

Masdar is an Abu Dhabi-based energy company that develops low-carbon solutions. It is a wholly owned subsidiary of Mubadala Development Company.
