



AECOM Supports Two California High-Speed Train Contracts Worth over \$70 Million in Total

LOS ANGELES--(BUSINESS WIRE)--Mar. 17, 2009-- AECOM Technology Corporation, a leading provider of professional technical and management support services for government and commercial clients around the world, announced today that it will provide tier-two environmental services and preliminary engineering to the California High Speed Rail Authority for the Altamont Corridor and Caltrain Corridor projects. The two high-speed train contracts are worth more than \$70 million to AECOM.

AECOM is leading the \$56-million Altamont Corridor contract, an 80-mile portion of the high-speed rail system that will connect the Central Valley to the San Francisco Bay Area via the Altamont Pass. Additionally, AECOM, working in partnership with HNTB, is expected to earn approximately \$16 million from the Caltrain Corridor, a 50-mile portion of the high-speed rail system that will connect San Jose to San Francisco.

"We are proud to have a continuing role in what will be one of the most important new transportation systems in the United States," said AECOM President and Chief Executive Officer John M. Dionisio. "AECOM is always eager to be involved with initiatives that enhance and sustain our built, natural and social environments, and this train system is projected to remove nearly 70 million drivers from the roads and eliminate almost 12.7 billion pounds of green house gas emissions in California. These are the type of projects that define our company."

AECOM's history with California's pursuit of a high-speed train system began in 2000 with programmatic work including alternatives analysis, conceptual engineering and developing tier-one environmental studies for more than 400 miles of the proposed system, between Sacramento and Los Angeles.
