On December 15, 2020, the restricted stock units vested and were settled for an equal number of shares of the Issuer's common stock less any applicable tax withholding.
- Represents shares of common stock withheld by the Issuer to satisfy certain tax withholding obligations in connection with the vesting of the restricted stock units.
- Shares acquired pursuant to AECOM's Performance Earnings Program under the 2016 Stock Incentive Plan.
- Pursuant to the terms of AECOM's Performance Earnings Program, the calculation to determine the number of shares awarded under the Program was performed using a per share value equal to the closing price on December 15, 2020.
- Each restricted stock unit represents a contingent right to receive, upon vesting, one share of the Issuer's common stock.
- The restricted stock units vest on December 15, 2023.
